### Trip Cost Coverage:

**Trip Cancellation Benefits:** In the event that your trip is canceled due to a "covered" issue (refer to Description of Coverage brochure for details), you will be reimbursed for the maximum limit for trips that are canceled before the scheduled, contracted departure date.

**Trip Interruption Benefits:** You will be covered for the maximum limit for trips that have been interrupted due to events or circumstances within the coverage plan.

### Medical Coverage:

**Medical Assistance:** Covers necessary medical expenses up to one year after the sickness or injury, provided injury or sickness occurred while on your trip and you received initial treatment while on your trip.

**Pre-existing Conditions:** will only be covered if the traveler purchases the insurance premium at the time of their initial payment to the group organizer, travel agent or EEI TRAVEL. At the time of a claim, the entity receiving the traveler's first payment must provide a receipt or invoice showing the date the group member first made their initial trip payment in order to verify the validity date for the pre-existing conditions rule. The insured's pre-existing conditions date rule is not affected by financial transactions between the group organizer and EEI TRAVEL for initial trip set-up such as deposit to hold or reserve product, airline seats, hotel blocks, etc.

### Baggage & Assistance:

**Baggage Coverage:** Reimburses you if your luggage is lost, damaged, or stolen while you are on your trip.

**Baggage Delay:** Reimburses you for the purchase of essential items if your checked bags are delayed for more than 24 hours.

**24-Hour Medical Assistance\*:** From medical monitoring to emergency medical payments, trip insurance covers these inopportune situations and more.

**24-Hour Legal Assistance\*:** If a situation should arise where you need legal assistance you will be provided with a referral to a local legal advisor, and advance of funds for bail and legal fees.

**24-Hour Travel Assistance\*:** Should you require assistance in retrieving lost or stolen travel documents, emergency cash or transfer message, even interpretation services, travel insurance will help coordinate these services.
